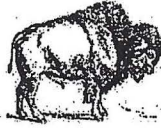

ORDINANCE # 09-09-01

AN ORDINANCE FOR BUFFALO COUNTY HIGHWAY COMMISSIONER POSITION

The Buffalo County Wisconsin Board of Supervisors does hereby ordain as follows:

WHEREAS, Wisconsin State Statute Chapter 83.01 requires each county to elect or appoint a county highway commissioner in order to participate in state allotments for highways, and

WHEREAS, unless the responsible county board establishes a different term of service for the position of highway commissioner, said term of service shall be for a two (2) year period, and;

WHEREAS, during 1994, Buffalo County enacted Ordinance #94-12-01 which established the term of highway commissioner as indefinite and appointed Mr. David Brevick to that position, and;

WHEREAS, the Buffalo County Highway Committee has reviewed existing Buffalo County Ordinance #94-12-01 and has approved the following:

NOW, THEREFORE, the Buffalo County Board of Supervisors ordains that the position of Buffalo County Highway Commissioner, as has been previously established, will continue unless and until such time as it is modified, eliminated or otherwise amended by the Buffalo County Board of Supervisors, and;

BE IT FURTHER ORDAINED, that an individual elected or appointed to the position of highway commissioner by a majority vote of all the members of the Buffalo County Board of Supervisors, and upon satisfactory completion of an initial two (2) year term of employment, shall serve as an at will employee, serving at the pleasure of the Buffalo County Board of Supervisors, until such time as the office becomes vacant for any reason, including but not limited to retirement, resignation, disability, death or removal, and;.

BE IT FURTHER ORDAINED, that Buffalo County Ordinance #94-12-01, entitled "Highway Commissioner Appointment" is hereby rescinded in its entirety effective immediately.

REPEAL OF CONFLICTING ORDINANCES. All other ordinances, or parts of ordinances, as previously adopted by the Buffalo County Board of Supervisors, which are in conflict with this ordinance, are also hereby repealed.
