ORDINANCE # 20-12-01

AN ORDINANCE TO AMEND ORDINANCE #09-09-01 FOR BUFFALO COUNTY HIGHWAY COMMISSIONER POSITION FROM TWO YEARS TO ONE YEAR

The Buffalo County Wisconsin Board of Supervisors does hereby ordain as follows:

WHEREAS, Buffalo County adopted Ordinance No. 09-09-01 on September 1, 2009 to establish the term of service of the Highway Commissioner for a period of two (2) years; and,

WHEREAS, Wisconsin State Statutes Chapter 83.01 requires each county to elect or appoint a county highway commissioner in order to participate in state allotments for highways; and,

WHEREAS, unless the responsible county board establishes a different term of service for the position of highway commissioner, said term of service shall be for a two (2) year period; and,

WHEREAS, the Buffalo County Highway Committee recommends that an individual elected or appointed to the position of highway commissioner by majority vote of all the members of the Buffalo County Board of Supervisors shall for an initial term of one (1) year with a satisfactory review after ninety (90) days and at six (6) months of employment; and,

WHEREAS, after successful completion after one (1) year of employment, the individual elected or appointed to the position of highway commissioner shall serve as an at will employee, serving at the pleasure of the Buffalo County Highway Committee and the Buffalo County Board of Supervisors, until such time as the office becomes vacant for any reason, including but not limited to retirement, resignation, disability, death or removal; and,

WHEREAS, all other ordinances, or parts of ordinances, as previously adopted by the Buffalo County Board of Supervisors, which conflict with this ordinance are hereby repealed.

NOW, THEREFORE BE IT RESOLVED, that the Buffalo County Board of Supervisors adopts this ordinance to amend the initial term of appointment from two (2) years to one (1) year with a satisfactory review after ninety (90) days and six (6) months.

BE IT FURTHER RESOLVED, that after one (1) year, the individual elected or appointed to the position of the highway commissioner shall serve as an at will employee, serving at the pleasure of the Buffalo County Highway Committee and the Buffalo County Board of Supervisors.

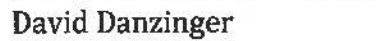
